### 3. Previous minutes and matters arising

- The minutes of Meeting No 5 were accepted and approved.
- Matters arising from meeting No5 of 20th May:
  - (a) Notice Boards. It was agreed that six were required, at least A1 size (approx 84cms x 59cms). **Steve Rodrick** was to obtain quotes - **Trevor** to contact him. **Peggy** to contact Lyn Turner of the Wycombe DC. Michael noted that the Village Hall Committee owned a post driver.
  - (b) Item 10 Any other business: Peter Davis had investigated the cost of producing a calendar. It was agreed that this was not practicable this year as it was now too late in the year and the cost for small numbers was too high (£3.62 each, colour calendar for order of 100).

### 4. Treasurer's report

Current balance: £518-50p. We spent £98-60p.

At the Fete we collected: £122. The committee agreed to donate £25 to the Village Hall.

Our membership stands at 103.

### 5. Membership Secretary and communication with members

Stephanie Morgan was welcomed as the Membership Secretary and was unanimously voted onto the Steering Committee.

*Post meeting note: The constitution permits a maximum of 11 members on the Steering Committee so Stephanie will be co-opted as a non-voting member of the committee.*

A number of members have asked us to produce a newsletter to inform them of progress and activities. **Action: Trevor and Kevin.** Our principal methods of communication have been via the website and in the Naphill and Walters Ash Gazette. About 70% of our members have given an email address so we will email it to them and post it to the rest. **Action: Stephanie.**

### 6. External communications

Trevor Hussey reported:

That he had written to Natural England, Sir Edward Dashwood of the West Wycombe Estate and the National Trust regarding permission to carry out work on the common.

Natural England could see no objection but we must get permission from the land owner Sir Edward first. We should produce a written programme of work with dates when the work would be carried out; this to be agreed and signed by Sir Edward. Sir Edward replied saying that we must first clear any work with Mr. Finken of Cookshall Farm Estates who has leased the common. The National Trust (who own the Umbrella Tree area) have as yet to reply. **Trevor** agreed to write a programme of work and contact Mr. Finken.

### 7. Chiltern Enjoyment and Understanding Award

We agreed to enter the whole Friends of Naphill Group to this competition, with particular reference to the website, map, walks and talks. **Peggy** to submit the form.
