# 6. Natural England-Dashwood-Forestry Commission meeting

The meeting on 12<sup>th</sup> July took place with Wessex Woodland Management, Natural England, the Chiltern Conservation Board and the Forestry Commission together with FoNC. The outcome was fairly positive and it seems quite likely that a long-term management plan could be produced and followed. FoNC has been asked to supply information about special and valuable features of the Common, eg significant trees, junipers, ponds, archaeological features etc., etc., that need to be protected. Trevor and Philip have started a list of veteran trees with 18 noted so far. The list could stretch to 40.

- Juniper and gorse
- Flora, Hairy Bindweed
- Fungi
- Vertibrates
- Invertibrates, possibly we have Purple Hairstreak butterflies
- Glades and broad paths
- Ponds
- Archaeology; banks, ditches, farmstead, tank tracks
